

## Minutes of the 51<sup>st</sup> SEIAA Meeting held on 25<sup>th</sup> February, 2011

The 51<sup>st</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 25<sup>th</sup> February, 2011 at 2.30 P. M. at the Authority's office in M.P. Pollution Control Board Building, Paryavaran Parisar, Bhopal chaired by Shri Amar Singh, Chairman SEIAA.

### **A. Cases recommended for Prior Environmental Clearance**

1. **Case no 242/08, M/s Om Prakash, Bhadrathia stone mine, Gwalior, M.P.,** Stone mine 8.00 ha. at village-Chandpara, Distt-Gwalior M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents observed that the Project Proponent has not submitted summary EIA report as indicated in Appendix III A of notification S O 1533 dt 14th September 2006 issued by MoEF, GOI.

It was also observed by the Authority that the Project Proponent has not submitted an attested/notarized copy of Mining Lease and latest copy of Khasra.

Hence it was decided by the Authority to write to Project Proponent to submit following documents by 15<sup>th</sup> May 2011:

- i. Summary Report of EIA which should be project specific.
  - ii. Attested/notarized copy of Mining Lease
  - iii. Attested/notarized latest copy of Khasra.
2. **Case no 267/09, M/s Shri P.C. Sharma, HIG-9, Housing Board Colony, Katni-M.P.,** Bauxite & ochre mine 16.187 hact. at Village- Amoch, Teh-Bahoriband, Distt-Katni-M.P

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents observed that the Project Proponent has not submitted summary EIA report as indicated in Appendix III A of notification S O 1533 dt 14<sup>th</sup> September 2006 issued by MoEF, GOI.

It was also observed by the Authority that the Project Proponent has not submitted an attested/notarized copy of Mining Lease and latest copy of Khasra.

  - iii. Attested/notarized latest copy of Khasra.
3. **Case no 272/09, M/s Deshgaon Basalt, Om Niwas, Ramkrishnaganj, Behind Mandi gate, Khandwa-M.P.**, Deshgaon Basalt metal stone quarry 19800 cum per annum 18.84 hact. at village Deshgaon Teh- Khandwa, Distt- Nimar –M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents observed following:-

- i. The EIA submitted by the Project Proponent is not project specific.
- ii. Executive summary of EIA not submitted.
- iii. The Project Proponent has not submitted Mining Plan as prescribed in the notification S O 1533 dt 14<sup>th</sup> September 2006 issued by MoEF, GOI.
- iv. Attested/notarized copy of Mining Lease and latest copy of Khasra.

Hence it was decided by the Authority to write to the Project Proponent to submit above mentioned documents (pt.no.i to iv) by 15<sup>th</sup> June 2011.

4. **Case no 288/09, M/s Ghai Enterprises, Station Road, Satna M.P.**, Limestone mine 12.595 hect. at village- Kharaundi, Taluka-Maihar, Distt-Satna- M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinising the documents observed that EIA submitted by the Project Proponent is very general. The Authority also went through summary of EIA submitted by the Project Proponent.

It was also observed by the Authority that the Project Proponent has not submitted attested/notarized copy of mining lease and certified/notarized copy of latest Khasra.

Hence it was decided by the Authority to write to the Project Proponent to resubmit summary of EIA which should be specific to the project and attested/notarized copy of Mining Lease and Khasra by 15<sup>th</sup> May, 2011 as indicated in the observation of the Authority.

5. **Case no 294/09, M/s K.C.Bagaria Sons Station Road, Katni-M.P**, Lime stone & Dolomite deposit mine 7.52 hect. village-Ametha, Teh- Vijayraghgarh, Distt- Katni-M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents observed that the Project Proponent has not submitted summary EIA report as indicated in Appendix III A of notification S O 1533 dt 14th September 2006 issued by MoEF, GOI.

It was also observed by the Authority that the Project Proponent has not submitted an attested/notarized copy of Mining Lease and latest copy of Khasra.

Hence it was decided by the Authority to write to Project Proponent to submit following documents by 15<sup>th</sup> May 2011.

- i. Summary Report of EIA which should be project specific.
- ii. Attested/notarized copy of Mining Lease
- iii. Attested/notarized latest copy of Khasra.

6. **Case no 447/09 Shri Sachin Dubey, C/o Nehru Colony, Thatipur, Gwalior-M.P.**, Laterite fire clay mine 11.13 ha. at Vill- Padwar, Teh-Bahoriband, Distt- Katni-M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority went through EIA report submitted by the Project Proponent, and also scrutinized summary report of EIA and observed that anticipated impact by the activity are not quantified and mitigative measures have not been given.

It was also observed by the Authority that the Project Proponent has not submitted an attested/notarized copy of Mining Lease and latest copy of Khasra.

Hence it was decided by the Authority to write to Project Proponent to submit following documents by 15<sup>th</sup> May 2011.

- i. Revised summary of EIA report which should be specific to the project, mitigative measures should be quantified, year wise scheme of plantation which include species and no.of plants.
- ii. Attested/notarized copy of Mining Lease
- iii. Attested/notarized latest copy of Khasra.

The Authority also observed that the Project Proponent has not submitted the distance of mining lease area from forest boundary and the protected area under Wild Life Protection Act, 1972. Hence it was decided to write a letter to DFO, Katni to inform these actual distances of Mining Lease area.

7. **Case no 492/09, Shri Sanktha Prasad Dwivedi, Distt-Satna-M.P.**, Jura lime stone mine 29.163 ha. at village Jura, Teh- Maihar, Distt- Satna-M.P.

The above case was considered in 76th meeting of SEAC and recommended for grant of Prior Environmental Clearance.

The Authority while scrutinizing the documents observed that -

- i. Summary submitted by the Project Proponent is not specific to the project and anticipated impacts are not in measurable term.
- ii. The Project Proponent has not submitted attested/notarized copy of Mining Lease and latest copy of Khasra (attested/notarized).
