

## **Minutes of the 56<sup>th</sup> Meeting of SEIAA ( 07-04-2011)**

The 56<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 7<sup>th</sup> April, 2011 at 11.00 A. M. at the Authority's office in M.P. Pollution Control Board Building, Paryavaran Parisar, Bhopal chaired by Shri Amar Singh, Chairman SEIAA.

**Cases to be reconsidered by SEIAA, which fall in the new critically polluted area and at a prescribed distance from its boundary according to the provisions of Office Memorandum MoEF, GoI dated 13-01-2010 and its clarification dated 15-03-2010 by the MoEF, GoI.**

1. **44/2008, M/s Parsvnath Developers Ltd, New Delhi**, Residential Township "Parsvnath City" phase-I at village Raukhedi Teh. Sanwer, Distt. Indore-M.P.

The case was discussed in 30<sup>th</sup> SEIAA meeting held on 09-03-2011. Certain decisions were taken to seek additional information. On re-consideration it is to be examined if SEIAA has jurisdiction to grant E.C.

Hence the Authority, while scrutinizing the documents, has observed that the proponent has not clearly mentioned distance of proposed project from Indore city, railway station, airport separately. Hence it was decided by the authority to write to:

- (1). Project proponent to submit information as per Form 1 of notification dated 1.12.2009 of MOEF, GOI by 31<sup>st</sup> May 2011.
- (2). Collector, Indore to know distance of the project area ( M/s Parsvnath City" phase-I at village Raukhedi, Teh. Sanwer, Distt. Indore) from Indore Municipal Corporation limit.
- (3). Joint Director, Industries, Indore to know distance of proposed project, (M/s Parsvnath City phase-I at village Raukhedi Teh. Sanwer, Distt. Indore) from Industrial Area, Sanwer Road, Indore.

2. **495/2010, M/s Saicharan properties Ltd, 101, Kalptaru Synergy, Opp. Grand Hyatt, Santacruz (E), Mumbai- 400 055**, Commercial building of plot no. 27, at Yash Niwas Road, Indore-M.P.

The Authority while scrutinizing the documents observed that the proponent has provided information in the Form-1 that location of the project is in Indore city (plot no. 27 at Yash Niwas road, Indore) which is critically polluted area.

The notification of MoEF, GOI dated 14th September 2006 mentions General Condition and according to it any project or activity specified in Category `B` will be treated as Category `A` if located in whole or in part within 10 km from the boundary of - (ii) critically polluted areas as notified by CPCB from time to time. Hence, the project would be treated as Category `A` and a decision for Prior Environmental Clearance could be taken by MoEF, GOI. The Authority decided to return the application along with all the documents to the Project Proponent.

3. **94/2008, Tirupati Balaji Enterprises, 68-B, 69-A, Sector-F Industrial area, Sanwer Road, Indore-M.P.**, Small scale unit for manufacturing 1200 TPA reclaimed Lead Acid Batteries, Plot No. 68-B, 69-A, Sctor-F, Industrial area Sanwer Road, Indore-M.P.

The Authority while scrutinizing the documents has observed from information provided by the proponent in Form-1 that the project city is located at industrial area Sanwer Road, Indore which is critically polluted area. The notification of MoEF, GOI dated 14th September 2006 mentions General Condition and according to it any project or activity specified in Category `B` will be treated as Category `A` if located in whole or in part within 10 km from the boundary of - (ii) critically polluted areas as notified by CPCB from time to time. Hence, the project would be treated as Category `A` and a decision for Prior Environmental Clearance could be taken by MoEF, GOI. The Authority decided to return the application along with all the documents to the Project Proponent. The PP had submitted EAR in January, 09 but this was not considered till yet by SEAC. Letter is to be sent to the Member Secretary, SEAC to send reasons for this by 31.5.11. This should be placed before SIEAA in June, 11.

4. **88/2008, Lucky Enterprises, Indore-M.P.**, Small scale unit for manufacturing 1000 TPA Reclaimed Lead at Plot no.33/4, Sector-F, Industrial Area, Sanwar Road, Indore – M.P

The Authority while scrutinizing the documents has observed from information provided by the proponent in form 1 that indicated the project city is located at industrial area Sanwer Road, Indore which is critically polluted area. The notification of MoEF, GOI dated 14th September 2006 mentions General Condition and according to it any project or activity specified in Category `B` will be treated as Category `A` if located in whole or in part within 10 km from the boundary of - (ii) critically polluted areas as notified by CPCB from time to time. Hence, the project would be treated as Category `A` and a decision for Prior Environmental Clearance could be taken by MoEF, GOI. The Authority decided to return the application along with all the documents to the Project Proponent.

7. **479/2009, Shri Hari Prakash Shivhare, Vasant Vihar, D-46, Kabir Niwas, Distt-Gwalior-M.P.** Pathar Muram Mine 20 hect. at Village Rajiyar, Teh- Dabra, Distt-Gwalior-M.P.

The case was discussed in 71<sup>st</sup> meeting of SEAC. It is stated that Project Proponent has not applied in new form and also has been given more than three chances to attend the meeting but Project Proponent did not respond the matter. Hence the case is proposed for rejection. The committee decided to send back the case to SEIAA.

The Authority has examined records of the proposed case and accepted recommendation of SEAC. It is decided to close the case.

8. **561/2010, Gayatri minerals, C/o Shankarlal Vishwakarma, Jalpadevi ward, Gautam Mohalla, Distt-Katni-M.P.**, Bauxite laterite mine 9.70 ha. at village Tikar, Teh- Huzoor, Distt-Rewa-M.P.

The case was discussed in 71<sup>st</sup> meeting of SEAC. It is stated that Project Proponent has been given three chances to attend the meeting. The case is proposed for rejection. The committee decided to send back the case to SEIAA.

The Authority has examined records of the proposed case and accepted recommendation of SEAC. It is decided to close the case.
