
The case was discussed in 542<sup>nd</sup> SEIAA meeting dtd 26.04.2019 and it has been recorded that.....

Earlier PP was also absent in 350<sup>th</sup> SEAC meeting dated 15/03/2019 and 354 SEA meeting dated 28.03.2019. Committee decided that since sufficient opportunities has been given to the PP for appraisal of their case but PP remains absent thus committee decided that case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.:*

**As per above decision, the case is hereby delisted and shall be liable for relisting if PP intends to present the case in SEIAA.**


