"-----During the presentation, it was observed from Google earth that 01 more lease having 3.71 ha area of M/s Balaji Stone Works exists within 500m of the proposed mine which forms cluster situation having more than 5.00 ha area of mining lease. After detailed discussion, it was decided to seek clarification from Collector, Singrauli about current status of other mines located within 500 m of proposed mine.

The required information is still awaited from Collector or PP. After discussion, it was decided to delist the case on the condition that if PP intends to present the case in SEIAA it will then be relisted for appraisal. Copy to PP and all concerned.

As per above decision, you are hereby informed that your case is delisted and liable for relisting if you intends to present the case in SEIAA.
