

विषयान्तर्गत प्रकरण में राज्य स्तरीय विशेषज्ञ मूल्यांकन समिति (SEAC) द्वारा 779वीं बैठक दिनांक 26.03.2025 में विशेष शर्तों सहित पर्यावरण स्वीकृति हस्तांतरण प्रदान किये जाने की अनुशंसा कर प्रकरण दिनांक 05.04.2025 को राज्य स्तरीय पर्यावरण समाघात निर्धारण प्राधिकरण (SEIAA) को अग्रेषित किया गया। प्रश्नाधीन प्रकरण SEIAA की बैठक में विचारण नहीं होने के कारण 45 दिवस से अधिक की अवधि समाप्त हो गई है।

पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय, भारत सरकार की ईआईए अधिसूचना दिनांक 14.09.2006 के पैरा 8 की कंडिका (iii) इस प्रकार है - "In the event that the decision of the regulatory authority is not communicated to the applicant within the period specified in sub-paragraphs (i) or (ii) above, as applicable, the applicant may proceed as if the environment clearance sought for has been granted or denied by the regulatory authority in terms of the final recommendations of the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned."

अतः ईआईए अधिसूचना के पैरा 8 की कंडिका (iii) के अनुसार उक्त प्रकरण में SEAC की 779वीं बैठक दिनांक 26.03.2025 में विशेष शर्तों सहित पर्यावरण स्वीकृति हस्तांतरण हेतु की गई अनुशंसा को अंतिम निर्णय मानते हुए राज्य स्तरीय समाघात निर्धारण प्राधिकरण (SEIAA) द्वारा "Deemed Approval" माना जाकर पर्यावरण स्वीकृति हस्तांतरण किया जाता है। तदनुसार प्रकरण में ईआईए अधिसूचना के पैरा 8 की कंडिका (iii) के अनुसार आगामी आवश्यक वैधानिक कार्यवाही करने हेतु आप स्वतंत्र हैं।

PP submitted that earlier Environment Clearance (EC) was granted by MoEF&CC, New Delhi in favour of M/s Ethan Natural Bio-Fuels Private Limited vide EC Identification No. EC22A060MP110018, F.No. IA-J-11011/338/2022-IA-II(I) dated:-27.09.2022 for setting up Greenfield Project of 150 KLD Grain Based Ethanol Plant along with 4.0 MW Co-generation Power Plant located at Village-Basi, Teh- Waraseoni, District- Balaghat, M.P. **Consent to Establish was obtained from Madhya Pradesh Pollution Control Board vide Consent No. CTE-57118 dated 21.11.2022.** Consent to Operate was obtained vide Consent No. AWH-59542 dated 13.01.2024. Thereafter, name of the company was changed from M/s Ethan Natural Bio-Fuel Private Limited to M/s Jakson Biofuels Private Limited on 27.08.2024. Hence, As per the provisions laid down under EIA Notification dated 14th September 2006 & amendment till date PP has initiated the process of transfer of Environment Clearance from M/s Ethan Natural Bio-Fuel Private Limited to M/s Jakson Biofuels Private Limited.

Subject to the following special conditions:**

- All the terms and condition as mentioned in the environment clearance issued by MoEF&CC, New Delhi EC Identification No. EC22A060MP110018, F.No. IA-J-11011/338/2022-IA-II(I) dated 27.09.2022 for setting up Greenfield Project of 150 KLD Grain Based Ethanol Plant along with 4.0 MW Co-generation Power Plant located at Village-Basi, Teh- Waraseoni, District- Balaghat, M.P. shall remain unchanged and validity of EC shall be as per the EIA notification 2006 and as per amendment in future in any.
- The recommendation for the transfer of EC does not certify that PP has not violated any provision of the EC at any point of time in the past. If at any point of time it is found that PP has violated the provision of EC, PP shall be liable for the same.
- The compliance of the conditions of environment clearance along with the Photographs of plantation and CER activities progress shall be submitted to the Parivesh Portal, Regional Office of MOEF&CC and M.P. SEIAA on six monthly basis by the New Project Proponent as per provision of EIA notification 2006 and office memorandum 14.06.2022 of MoEF&CC Govt of India.
