**OFFICE MEMORANDUM**

**Subject: Prior Environmental Clearance for cases pending at Madhya Pradesh -SEIAA / Madhya Pradesh -SEAC - regarding.**

This has reference to the communication received from the SEIAA – Madhya Pradesh, vide letter No. 63/SEIAA/2014 dated 18.7.2014 in the above referred subject. It has been observed that on expire of tenure of the SEIAA, Madhya Pradesh on 11.11.2013, the pending proposals were delisted by the SEIAA, Madhya Pradesh and vide their Notice No. 1999/SEIAA/13 dated 23.11.2013 and No. 2001/SEIAA/2013 dated 5.12.2013 informed all the project proponents that those who would like to seek environmental clearance shall apply to the MoEF&CC until the reconstitution of SEIAA, Madhya Pradesh. Further, it was informed to seek / collect list of necessary documents / information available with SEIAA / SEAC, Madhya Pradesh based on the instruction of MoEF&CC for considering such cases.

2. Now, SEIAA / SEAC, Madhya Pradesh has been re-constituted vide. S.O. 1650 (E) dated 30.6.2014 and is in the process of granting prior Environmental Clearance under EIA Notification, 2006. Accordingly, the cases would be relisted and considered in the SEIAA, Madhya Pradesh.

3. In view of the above, it is requested that the proposals of Category 'B' projects received in the Ministry, if any, during the period from the State of Madhya Pradesh and pending with MoEF&CC on which final decision has not taken, may immediately be returned to the SEIAA, Madhya Pradesh and informed the project authorities to approach concerned SEIAA. Such proposals may be delisted and the information be sent directly to the Member Secretary, SEIAA, Madhya Pradesh within 15 days from the issue of the O.M. for taking further necessary action at their end.
