"Mining Officer, Hoshangabad has submitted application for transfer of Prior EC in the name of Sarpanch, Gram Panchayat - Powarkhedakhurd, Janpad Panchayat Babai, Hoshangabad from M/s Sainik Foods Pvt. Ltd, Sub Lessee of MPASMCL of HIG-D-5, Dindayal Nagar, Phase -1 Kantha Road, Muradabad - UP through vide letter No. 1812 dated 22.01.2018. After examination of all documents submitted by the Mining Officer, Hoshangabad, it is observed that the Prior EC was issued vide letter No. 5416 dated 02.03.2017 & and corrigendum no. 05 dtd 01.04.2017 to M/s Sainik Foods Pvt. Ltd, Sub Lessee of MPASMCL, and the above mining lease has sanctioned for 10 years from 25/02/08 to 24/02/2018. It is evident that above sand mining lease has been expired on 24/02/2018. Hence prior EC issued to M/s Sainik Foods Pvt. Ltd, Sub Lessee of MPASMCL is hereby cancelled due to non existence of mining lease in their name and prior EC cannot be transferred to Gram Panchayat, Powarkhedakhurd, Janpad Panchayat Babai, Hoshangabad.
