- (1) It was noted that the PP had applied in Form-I (DEIAA - Case no 57/2018) for Prior Environmental Clearance Sand Mine in an area of 3.990 ha for production capacity of 113715 cum/year at Khasra no. 609 at Village- Barua, Tehsil- Gaurihar, District- Chhatarpur (MP) by Sarpanch, Gram Panchayat, Barua, Tehsil- Gaurihar, Dist. Chhatarpur..
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 2577/DEIAA/18 dtd.06.06.2018 in the name of "Sarpanch, Gram Panchayat, Barua, Tehsil- Gaurihar, Dist. Chhatarpur."
- (3) It is noted that PP has requested vide no nil dtd.nil received in SEIAA office 22.06.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022." in place of "Sarpanch, Gram Panchayat, Barua, Tehsil- Gaurihar, Dist. Chhatarpur"

Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022 ".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

**Para-11 :-** A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA(Case no. 57/2018) on 06.06.2018 in the name of " Sarpanch, Gram Panchayat, Barua, Tehsil- Gaurihar, Dist. Chhatarpur.." is hereby transferred to M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022-" for Sand Mine in an area of 3.990 ha for production capacity of 113715 cum/year at Khasra no. 609 at Village- Barua, Tehsil- Gaurihar, District- Chhatarpur (MP) " on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, the Prior Environmental Clearance issued to Sarpanch, Gram Panchayat, Barua, Tehsil- Gaurihar, Dist. Chhatarpur. DEIAA(Case no. 57/2018) on 06.06.2018 for Sand Mine in an area of 3.990 ha for production capacity of 113715 cum/year at Khasra no. 609 at Village- Barua, Tehsil- Gaurihar, District- Chhatarpur (MP) is hereby transferred to M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022. on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
