As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferoe with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC transferred by DEIAA, Jabalpur on 22.01.18 in the name of "Sarpanch, Gram Panchayat, Sagda Jhapni, Tehsil - Jabalpur, Dist. - Jabalpur (MP)" is hereby transferred to "Aaradhya Logistic Solution Pvt. Ltd., Authorized Person - Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP - 482001" for Sand Quarry in an area of 2.023 ha. for production capacity of 23,000 cum/year at khasra no. 1/1 at Village - Sagda Jhapni, Tehsil - Jabalpur, Dist. - Jabalpur (MP) on the same terms & conditions, production capacity and validity period under which the prior Environmental Clearance was initially granted".

Hence, it was decided to transfer the Prior EC in the name of Aaradhya Logistic Solution Pvt. Ltd., Authorized Person - Shri Brajesh Sohaney, 1967, Right Town, Jabalpur, MP - 482001 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
