Case No . 7227/2020: Prior Environmental Clearance for Sand Quarry (Opencast Manual Method) in an area of 5.0 ha. for production capacity of 3125 cum/year at Khasra No. 62, 64 at Village-Imaliya, Tehsil-Maksudangarh, District- Guna (MP) by M/s Vijay Builders, Authorized person Shri Sandeep Singh Chouhan R/o 15, Gram Bamlabe, Tehsil - Vyawara, Dist. - (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 5.0 ha. for production capacity of 3125 cum/year at Khasra No. 62, 64 at Village- Imaliya, Tehsil- Maksudangarh, District- Guna (MP) by Sarpach/Sachiv Gram Panchayat kitakhedi Tehsil-Maksudangarh, District- Guna MP.
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No.Mining/3-6/72 dtd.22.1.2018 in the name of Sarpach/Sachiv Gram Panchayat kitakhedi Tehsil-
- (3) It is noted that PP has requested to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s Vijay Builders, Authorized person Shri Sandeep Singh Chouhan R/o 15, Gram Bamlabe, Tehsil - Vyawara, Dist. Rajgarh, MP-473001." in place of Sarpach/Sachiv Gram Panchayat kitakhedi Tehsil-Maksudangarh,
- (4) It is noted that in support of his request the PP has submitted the following documents
 - No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Vijay Builders, Authorized person Shri Sandeep Singh Chouhan R/o 15, Gram Bamlabe, Tehsil - Vyawara, Dist. Rajgarh, MP-473001.
 - Notarised affidavit of CEO, Janpad Panchayat, District-Guna MP".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior III.
 - Copy of Prior EC issued by DEIAA vide letter No. Mining/3-6/72 dtd.22.1.2018. IV.
 - Copy of Environmental Management Plan of M/s Vijay Builders, Authorized person Shri Sandeep Singh Chouhan R/o 15, Gram Bamlabe, Tehsil - Vyawara, Dist.

- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
- Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA on 22.1.2018 in the name of " Sarpach/Sachiv Gram Panchayat kitakhedi Tehsil-Maksudangarh, District- Guna." is hereby transferred to M/s Vijay Builders, Authorized person Shri Sandeep Singh Chouhan R/o 15, Gram Bamlabe, Tehsil - Vyawara, Dist. Rajgarh, MP-473001 for Sand Quarry in an area of 5.0 ha. for production capacity of 3125 cum/year at Khasra No. 62, 64 at Village- Imaliya, Tehsil- Maksudangarh, District- Guna (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.
