With reference to above the proposal has been appraised as per prescribed procedure & provisions under the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006 and its amendment, on the basis of the mandatory documents enclosed with the application viz., Form I, Form IA, Conceptual Plan, drawings and subsequently submission of EIA & the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- The proposed project is building construction of "Central Academy for Police Training of Bureau of Police, Research and Development", Ministry of Home Affairs, Government of India having total land area106.15 ha and built up area is 59383.84 sg.m. by virtue of the size of plot area (more than 50 hectares) the project comes under 8(b) category (B) of schedule of EIA Notification, 2006.
- As per the T & CP Bhopal Sehore (vide letter no. 2327 dtd. 14.11.14, the total land area is 106.15 ha at Khasra No. 197, 198, 204, 261, Village Kanhasaiya, Tehsil Huzur, Distt. Bhopal (MP). The state government of Madhya Pradesh has provided about 401 acres land spread in three Plots-A, B & C of approximately area 118, 267 & 16 acres respectively near village Kanhasaiya, Tehsil Huzoor, Distt. Bhopal for setting up the Central Academy. The main academy is proposed in Plot- B comprising of Khasra nos 204, 197, 198, 199 and 261 having an area of 106.15 hectares. As per Khasra Panchsala (2013-14) the Khasra no. 197 is in the name of

The project includes Construction of Residential building, Administrative & academic building, Amenities and hostel buildings.

- iii. The source of water supply is Ghoda-Pachhar Reservoir located at distance of 1.75 km (Water Resource Deptt. letter dtd. 17.07.13). The total water requirement is 203.74 KLD (fresh water 111.74 KLD). The waste water generation is 127.74 KLD and STP capacity is 150 KLD. The total treated waste water is 121.35 KLD, which is proposed to be recycled (100%) for flushing, horticulture etc. PP has provided detention pond to supplement the horticulture need hence there will be no discharge of treated waste water.
- iv. The MSW (607 kg per day) is proposed to be segregated at source into biodegradable and non biodegradable components and collected in separate bins. Final disposal shall be through Municipal Corporation, Bhopal.
  - Hazardous waste from campus will consist of waste oil from DG sets, resin from Water Treatment Plant. PP has proposed that the entire volume of the hazardous waste shall be disposed off at TSDF, Pithampur.
- v. As per T & CP approval the maximum height of the building is 18 m. PP has proposed 12.0 m height. PP has provided road width 24 m; Front MOS 12 m and side / rear MOS 6.0 m.
- vi. Static tank (underground) and overhead tank, Landing valves with hose reels, External hydrant all around the building & yard, automatic sprinkler system, Pumping arrangement system- riser system with pressure pump, auto operation with pressure switch etc. as per NBC 2005 are proposed for firefighting.
- vii. PP has proposed to provide total car parking of 563 ECS. (Institutional Block- 203 ECS; Hostel Blocks- 189 ECS; Allied Blocks- 83 space ECS, Commercial Block 13 space ECS, Residential Apartment-75 space ECS).
- viii. PP has proposed rooftop rain water harvesting through 20 nos. of recharging pits for artificial recharge of ground water.
  - ix. The total power requirement is 5200 KW. PP has also proposed power back up 2 DG Sets 750 KVA each and Solar lighting panel 20 KW for street lighting. The source of power supply is MP Electricity Board.
  - x. Out of the total project area (106.15 ha) an area of 12.10 ha is proposed to be developed as green area.

Based on the information submitted at Para ii to x above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 195<sup>th</sup> meeting held on 20.04.15 and decided to accept the recommendations of 176<sup>th</sup> SEAC meeting held on dtd 26.02.15.

Hence, Environmental Clearance is accorded under the provisions of EIA notification dtd. 14th September 2006 to the proposed "Central Academy for Police Training of Bureau of Police, Research and Development", Ministry of Home Affairs, Government of India at Khasra No. 197, 198, 204, 261, Village Kanhasaiya, Tehsil Huzur, Distt. Kanhasiiya, Tehsil Huzur, Distt. Bhopal (MP) subject to the compliance of the Standard Conditions enclosed at **Annex-I** and the following additional Specific Conditions as recommended by SEIAA & SEAC in its meetings.

#### A. Specific Conditions as recommended by SEIAA

- (1) PP should ensure that the entire water demand is met through Water Resource Department and there is no extraction of ground water.
- (2) PP should ensure zero discharge of treated waste water. PP should ensure linkage with municipal sewer line in case of discharge of extra treated waste water (if any).
- (3) PP should provide compactors for MSW and ensure linkage with Bhopal Municipal Corporation Bhopal for final disposal of MSW.
- (4) PP should obtain authorization from MPPCB regarding Hazardous waste management.
- (5) PP should ensure road width and open spaces as per MP Bhumi Vikas Niyam 2012.
- (6) PP should ensure fire fighting provision as per National Building Code (2005) and MPBVR, 2012 and ensure that all the fire fighting measures are physically in place.
- (7) PP should ensure rain water harvesting.
- (8) PP should ensure installation of photovoltaic cells (solar panels) for lighting in common areas, LED light fixtures and energy efficient equipments.
- (9) PP should ensure car parking as per Rule no. 84 (1) Table Clause 1 (3) of MPBVR 2012.
- (10) PP should ensure maximum plantation all along the periphery of the project area, parks, playground and avenue plantation along the roads. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc. Every effort should be made to protect the existing trees on the plot.

#### B. Specific Conditions as recommended by SEAC

- (11) Mobile toilets / latrines shall be provided for the site-workers during construction phase.
- (12) Common toilets / latrines shall be provided for general visitors / service providers during operation.
- (13) Separate facilities shall be provided for the two segments of the project.
- (14) Adequate Parking space shall be provided such that no vehicles are parked on road sides and free movement of fire-tenders is ensured in case of fire emergency.
- (15) Grit-chamber has to be provided essentially in the STP.
- (16) Fresh water requirement for the project shall not exceed 111.74 KLD.

- (17) Press-filter dried STP sludge and the MSW shall not be stored at site for more than 48 hours; accordingly space of appropriate size shall be developed at suitable location within the project premises.
- (18) Appropriate play spaces shall be developed in the project.
- (19) Clearances / Pre- Clearances shall be obtained as applicable.
- (20) All the directions issued by Hon'ble Supreme Court of India/National Green Tribunal/Ministry of Environment, Forest & Climate Change, New Delhi from time to time shall be applicable.

Annex-I

Standard Conditions related to under item 8 (a) & 8 (b) of the schedule of EIA notification, 2006 (Building/ construction projects / area development projects & township)

#### A. Construction Phase

- The construction site shall be provided with adequately barricades of at least 3 m height on its periphery with adequate signage.
- 2. All required sanitary and hygienic measures should be in place before starting any construction work and are to be maintained throughout the project phase.
- Provision shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- 4. Occupational health and safety measures for the workers including identification of work related health hazards, training on malaria eradication, HIV, and health effects on exposure to dust etc. shall be carried out. Periodic monitoring for exposure to respirable dust on the workers shall be conducted and records maintained including health records of the workers. Awareness programme for workers on impact of dust on their health and precautionary measures like use of personal equipments etc. shall be carried out periodically.
- A First Aid Room will be provided in the project both during construction and operation of the project.
- 6. All the topsoil excavated during construction activities should be stored for use in horticulture/landscape development within the project site.
- 7. Disposal of muck during construction phase should not create any adverse effect on the neighbouring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of competent authority.
- Soil and ground water samples will be tested to ascertain that there is no threat to ground water quality by leaching of heavy metals and other toxic contaminants.
- Construction spoils, including bituminous material and other hazardous materials, must not be allowed to contaminate water courses and the dump sites for such material must be secured so that they should not leach into the ground water.

 Any hazardous waste generated during construction phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.

- 11. The desel generator sets (if any) to be used during construction phase should be low sulphur diesel type and should conform to Environment (Protection) Rules prescribed for
- 12. The diesel required (if any) for operating DG sets shall be stored in underground tanks and if required, clearance from Chief Controller of Explosives shall be taken.
- 13. Wastewater generated from temporary leabour tents will be diverted to the sewer network
- 14. No water logging should take place at any point during construction phase.
- 15. If the project site is located within the 100 km of Thermal Power Stations, then fly ash should be used as building material in the construction as per the provisions of Fly ash Notification of September, 1999 and amended as on 27th August, 2003.
- 16. As far as possible ready mixed concrete should be used in construction work.
- 17. Vehicles hired for bringing construction material to the site should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards and should be operated only during non-peak hours.
- 18. Ambient noise levels should conform to residential standards both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during construction phase. Adequate measures should be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/ MPPCB.
- 19. Storm water control and its use should be as per CGWB and BIS standards for various
- 20. Water demand during construction should be reduced by use of pre-mixed concrete,
- 21. Care shall be taken during the wet drilling activities.
- 22. Spread of contaminated water should be prevented by installing temporary barriers of
- 23. To prevent surface and ground water contamination by oil/grease, leak proof containers shall be used for storage and transportation of oil/grease. The floors of oil/grease handling area will be kept effectively impervious.
- 24. On-site burning of waste material will not be permitted.
- 25. Ground water should not be used during construction phase. Private tanker water suppliers may be asked to supply water during construction phase.
- 26. Commitment towards CSR have to be followed strictly.

27. Fixtures for showers, toilet flushing and drinking should be of low flow either by use of aerators or pressure reducing devices or sensor based control.

- 28. Wherever possible, the area around the STP / ETP should be surrounded with dense
- 29. To reduce the electricity consumption and load on air conditioning, high quality double glass with special reflective coating in windows should be promoted.
- 30. Roof should meet prescriptive requirement as per Energy Conservation Building Code by using appropriate thermal insulation material to fulfill requirement.
- 31. Opaque wall should meet prescriptive requirement as per Energy Conservation Building Code which is proposed to be mandatory for all air-conditioned spaces while it is aspirational for non-air conditioned spaces by use of appropriate thermal insulation
- 32. Approval of the competent authority shall be obtained for structural safety of the buildings due to earthquake, adequacy of fire fighting equipments, etc. as per National Building Code including protection measures from lightening etc.

### B. Operation Phase

- 1. The installation of the Sewage Treatment Plant (STP) as submitted by PP in the office of SEIAA should be certified by an independent expert and a report in this regard should be submitted to the Regional office of the Ministry of Environment & Forest, Gol before the project is commissioned for operation. Treated effluent discharge from STP shall be recycled/reused to the maximum extent possible. Treated effluent shall conform to the norms and standards of the M.P. Pollution Control Board. Necessary measures should be made to mitigate the odour problem from STP.
- Treated waste water should not be used for air conditioning.
- Treatment of 100% grey water by decentralized treatment should be done.
- 4. The bio-medical waste (if applicable) generated should be disposed off as per the provisions of Bio-medical waste (Management and Handling) Rules 1988 as amended till
- 5. Provision of separate entrance / exit gate should be made for collection of segregated bio-medical waste (if applicable) from the storage area.
- 6. The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry/inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material as per CPCB norms.
- Diesel power generating sets if proposed as source of back up power for elevators and common area illumination during operation phase should be of enclosed type and confirm to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Low sulphur diesel must be used. The location of the DG sets may be decided with in consultation with Madhya Pradesh Pollution Control Board.

- No water logging should take place at any point during operation phase.
- The Project Proponent shall explore the possibility of using solar energy wherever possible.
- 10. Provision for plantation has to be made as per Madhya Pradesh Bhumi Vikas Niyam,
- 11. Any hazardous waste generated during operation phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.
- Noise should be controlled to ensure that it does not exceed the prescribed standards of CPCB.
- 13. Weep holes in the compound walls shall be provided to ensure natural drainage of rain water in the catchment area during the monsoon period.
- 14. Rain water harvesting for roof run- off and surface run- off, should be implemented. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease. The bore well for rainwater recharging should be kept at least 5 mts. above the highest ground water table.
- The ground water level and its quality should be monitored regularly in consultation with Central Ground Water Authority.
- 16. Traffic congestion near the entry and exit points from the roads adjoining the proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.
- 17. A Report on the energy conservation measures confirming to energy conservation norms finalize by Bureau of Energy Efficiency should be prepared incorporating details about building materials & technology, R & U Factors etc and submit to the Regional office of Ministry of Environment & Forest, GoI in three months time.
- 18. Energy conservation measures like installation of CFLs/TFLs for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/ rules of the regulatory authority to avoid mercury contamination. Use of solar panels may be done to the extent possible.
- 19. The building should have adequate distance between them to allow movement of fresh air and passage of natural light, air and ventilation.
- The area earmarked for the parking shall be used for parking only. No other activity shall be permitted in this area.
- Ozone Depleting Substances (Regulation & Control) Rules shall be followed while designing the air conditioning system (if any) of the project.

#### Others

- 1. All activities / mitigative measures proposed by PP in Environmental Impact Assessment (if applicable) and approved by SEAC must be ensured.
- 2. All activities / mitigative measures proposed by PP in Environmental Management Plan and approved by SEAC must be ensured.
- 3. All parameters listed in Environmental Monitoring Plan approved by SEAC must be monitored at approved locations and frequencies.
- 4. Project Proponent has to strictly follow the direction/guidelines issued by MoEF, CPCB and other Govt. agencies from time to time.
- 5. The funds earmarked for environmental protection measures shall be kept in separate account and shall not be diverted for other purpose. Year wise expenditure shall be reported to the MoEF, GoI, and its Regional Office located at Bhopal.

- 10. The Project Proponent shall inform to the Regional Office, MoEF, Gol, Bhopal and MP PCB regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- 11. In the case of expansion or any change(s) in the scope of the project, the project shall again require prior Environmental Clearance as per EIA notification, 2006.

The SEIAA of M.P. reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environmental (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound
- 13. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department, Forest Conservation Act, 1980 and Wildlife (Protection) Act, 1972 etc. shall be obtained (as and when applicable), by the project proponent from the respective competent authorities.

These stipulations would be enforced among others under the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1,991 and EIA Notification, 2006.

- 17. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and municipal bodies as applicable in addition to the relevant officers of the Government who in turn has to display the same for 30 days
