Sub: Case No. – 2982/2015 Prior Environmental Clearance for Laterite & Ochre Mine (Opencast Mechanized Method) in an area of - 7.33 Ha. for production capacity - 67,611 TPA, at Khasra no.- Block A: 122/3 Part, 122/4 Part, and 147/2 Part & Block B: 125 Part, at Vill.-Dharampura, Teh.-Sihora, District-Jabalpur (M.P.) by M/s Geomin Industries Pvt. Ltd. Mr. Abhiudya Agarwal (Authorized Signatory), R/o 270, Garha Fatak, Jabalpur (M.P.) – 482002.

This has reference to your application received in SEIAA office on 27.04.2015 and subsequent\ letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1, Mining Plan, EMP and the additional clarifications furnished in response to the observations of the State Level Expert Appraisal Committee (SEAC) and State Level Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- II. It has been noted that the proposal is for Laterite & Ochre in an area of 7.33 ha. The mining lease area is located in Khasra Nos. Block A: 122/3 Part, 122/4 Part, and 147/2 Part & Block B: 125 Part at Village- Vill.-Dharampura, Teh.-Sihora, District-Jabalpur (M.P.) (M.P.). Geographically mining lease area falls under the co-ordinates latitude 23°23'33.5" N to 23°23'29.1" N and longitude 80°00'1.3" E to 80° 00'47.7" E. There is no National Park/Sanctuary and interstate Boundary within 10 km radius. There is no forest boundary is 250 m. from the mine site, thus it is not attracted by the general conditions.
- III. The proposed project is for production capacity of 67,611 **TPA**. The mining will be carried out by Open cast mechanized method. The Mining plan is approved by the IBM, Office of Regional Controller of Mines, Jabalpur (videLetter No. MP/Jabalpur/Laterite/MPLN/G-13/13-14/6043 dtd. 30.10.2014) The area 2.65 ha. area shall be covered under plantation and 3000 saplings shall be planted at the end of lease period. The water requirement is 10.20 KLD (3.0 KLD Dust Suppression + 6.75 KLD Plantation + 0.45 KLD Drinking purpose), which shall be met by nearby village, Pit water and Borewell/Dug well.

The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006.

IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 404th meeting dtd. 24.01.2017 and decided to accept the recommendations of 55th SEAC-II meeting dtd. 15.10.2016.

Hence, Prior Environmental Clearance is granted for Laterite & Ochre Mine (Opencast Mechanized Method) in an area of - 7.33 Ha. for production capacity - 67,611 TPA, at Khasra no.- Block A: 122/3 Part, 122/4 Part, and 147/2 Part & Block B: 125 Part, at Vill.-Dharampura, Teh.-Sihora, District-Jabalpur (M.P.) for the lease period to M/s Geomin Industries Pvt. Ltd. Mr. Abhiudya Agarwal (Authorized Signatory), R/o 270, Garha Fatak, Jabalpur (M.P.) – 482002. subject to the compliance of following specific conditions as recommended by SEIAA & SEAC and subsequent Standard Conditions.

A. Specific Conditions

- Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- PP shall install the proper sign boards highlighting the dangers of trespassing by the villagers at 100 m. distance all around the lease area.
- Plantation programme as mentioned in comprehensive EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- 4. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. The two row plantation shall be carried out in the greenbelt area in current year.
- Greenbelt of 1.8523 ha will be reserved for peripheral plantation with proper fencing. It should be
 done in first year and proper arrangements of water should be made for the plantation purpose. At
 the end of lease period, PP should complete afforestation in 2.2985 ha. including re-habilitation of
 backfilled area and bench slope.
- 6. Garland drain (2x1.5 m.) and settling tank (4 nos., One of size 5x3x3.5 m. each and 4th intermediate settling tank of 15m x 7.5m x 3m) shall be constructed all around the mine. PP shall also ensure the proper cleaning and maintenance of garland drain and settling tank.
- Water sprinklers shall be used on permanent basis for controlling dust emission
- PP will ensure full payment upto 20 lacks for black topping of 3.2 kms approach road to MP Rural Road Development Authority for which PP has already contributed 10 lacks to MPRRDA.
- PP must ensure pit depth not more than 10 m. and well above the existing ground water table as per the CGWB report.
- Monthly air & water quality monitoring shall be carried out by PP in consultation with Regional Officer, MPPCB. Jabalpur.
- Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- Proper infrastructure with shelter and toilet facility shall be developed for the labourers...
- 13. Under CSR activity in addition to the proposed activities following activities should be added:
 - Skill upgradation programme for the villagers of nearby villages under Digital India Scheme.
 - (ii). Construction of Community center at Village Khermai.
 - (iii). PP shall constructed 50 Nos. of toilets at Village Dharmpura for communities families.
 - (iv). PP shall also provide separate toilet facility for girls and boys with proper arrangement of water (water tanks & Pumps) in the school of nearby village.
 - (v). Drinking water facilities for villagers of nearby villages.
 - (vi). All the above activities shall be carried out in consultation with Gram Panchayat and District Collector.
- PP has proposed a budget provision Rs 15.00 lakhs for the CSR activities.

- PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 16. Transportation of material shall be done in covered vehicles.
- 17. Necessary consents shall be obtained from MPPCB and the air / water pollution control measures have to be installed as per the recommendation of MPPCB.
- 18. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
- 19. Curtaining of site shall be done through thick plantation all around the boundaries of the lease area.
- 20. The OB should be properly stacked inside the ML area in barrier zone and disposed off as per the submitted plan.
- 21. The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
- 22. Appropriate activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 23. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 24. Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.

B. Standard Conditions

- 1. Controlled blasting techniques, as and when required, shall be carried out in the day time only.
- 2. Mining will be carried out as per the approved Mining Plan. In case of any violation of Mining Plan the Environmental Clearance given by SEIAA will stand cancelled.
- Effective safeguard measures, such as regular water sprinkling shall be carried out in critical areas
 prone to air pollution and having high levels of particulate matter such as loading and unloading
 point and all transfer points.
- 4. Where the quarry is in a hilly terrain and where some part of the hill is already cut for quarrying, further hill cutting shall not be done. In such cases, deepening the existing operational area may be preferably done.
- 5. Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for all proposals under consideration.
- The lease holder shall obtain necessary prior permission of the competent authorities for drawal of requisite quantity of water (surface water and groundwater), if required for the project.
- Parking of vehicles should not be made on public places.
- 8. Special Measures shall be adopted to prevent the nearby settlements from the impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.
- 9. Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- 10. Trenches / garland drains shall be constructed at foot of dumps to arrest silt from being carried to water bodies.
- 11. The project proponent will ensure necessary protection measures around the mine pit, waste dumps and garland drain.
- 12. Top soil / solid waste shall be stacked properly with proper slope and adequate safeguards and shall be utilized for backfilling (wherever applicable) for reclamation and rehabilitation of mined out area.
- 13. Plantation programme shall be carried out as per EMP. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.

- The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation.
- Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine 15.
- Persons working in dusty areas shall be provided with protective respiratory devices and they shall 16. also be imparted adequate training and information on safety and health aspects.
- Dispensary facilities for first-aid shall be provided at site. 17.
- A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of 18. the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government
- The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- Concealing factual data or submission of false/fabricated data and failure to comply with any of the 20. conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, 21. within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
