With reference to above the proposal has been appraised as per prescribed procedure & provisions under the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14<sup>th</sup> September 2006 and its amendment, on the basis of the mandatory documents enclosed with the application viz., Form I, Form IA, Conceptual Plan, drawings and subsequently submission of PPT & the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- i. The proposed project is Commercial and Residential Project "SHIVOM" located at Plot no. 578, MG Area, Tehsil and District Indore MP by M/S MSD Developers.
- ii. The geographical coordinates of the project site is latitude 22"43'23.58"N to 22"43'24.21"N and longitude 75"52'44.52"E to 75"52'48.27"E
- iii. As per the approval of T & CP Indore (vide letter no.4279/ Nagrin/ 2014/ dated 28.06.2014) the total land area of the project is 9290.30 ha The total built up area proposed by PP is 25,885 sq. m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 as the total construction is between 20,000 sq.m & 1,50,000 sq.m. PP has also obtained high-rise committee approval as per recommendation of committee dd. 03.04.2014.

- iv. The project includes constructions of total Flats units -120 and Shops/Office-80.At present 100 % construction have been done and also 100 % possession given to all
- v. The project is a case of violation on account of not securing prior environment clearance before beginning the constriction activities at site. The construction work was started at site and 1000% of construction work was completed before the application was submitted to MPSEIAA for grant of prior environmental clearance.
- vi. Committee considering the recent Gol, MoEF & CC Notification dated 8th March, 2018 recommends that case may be dealt as per the provisions laid down in this notification and the project may granted Terms of Reference for undertaking Environment Impact Assessment and preparation of Environment Management Plan on assessment of ecological damage, remediation plan and natural and community resource augmentation plan and it shall be prepared as a independent chapter in the EIA report by the accredited consultant and the collection and analysis of data for assessment of augmentation plan shall be done by an environmental laboratory accredited by the National Accreditation Board for Testing and Calibration Laboratories.
- vii. As per the provisions laid down in this notification and the project may granted Terms of Reference for undertaking Environment Impact Assessment and preparation of Environment Management Plan on assessment of ecological damage, remediation plan and natural and community resource augmentation plan and it shall be prepared as a independent chapter in the EIA report by the accredited consultant and the collection and analysis of data for assessment of ecological damage, preparation of remediation plan and natural and community resource augmentation plan shall be done by an environmental laboratory accredited by the National Accreditation Board for Testing and Calibration Laboratories.
- viii. The project falls under Item 8(a) and the category of the project is B as per EIA Notification, 2006. MoEF&CC issued notification vide S.0.804 (E) dated 14th March, 2017 for violation cases. The project was then considered under violation category. As per the said notification; the proponent applied under the violation window.
- ix. The application of ToR was presented 433<sup>rd</sup> SEAC meeting dated 19.05.2020, wherein ToR (For Violation) has been recommended.
- x. EIA report submitted by PP on 04.08.20 and forwarded to SEAC on 07.08.20.The case was discussed in SEAC 450<sup>th</sup> SEAC meeting dated 13.08.2020 and recommended the EC subject to the special conditions and submission of bank guarantee (BG) with three years validity of Rs. 17, 22, 950/- (equivalent to amount proposed in remediation and resource augmentation plan) with the MP Pollution control Board.

- xi. Regarding land documents PP has submitted sale deed dtd. 13.10.2011 executed between Smt Sumitra Raje Dalvi, Shshri Sharda Raje Holkar, smt. Sita Raje Ghatge, sushri Sushila Raje Holkar and M/s M.S.D Developers through Partner Sharad.
- xii. The total water requirement during operation phase is 96 KLD out of which 43 KLD is fresh water requirement. The source of water supply is Municipal Corporation, Indore PP has submitted letter dtd. 25.10.18 issued by Nagar Nigam, Indore for water supply.
- xiii. The waste water 76 KLD generated from the project shall be treated in STP of 100 KLD capacity (MBBR based technology) and treated 68 KLD waste water generated, out of which 32 KLD recycled water will be used for flushing and 03 KLD water will be used for washing, 17KLD for green area development and remaining extra treated water will be discharged into municipal sewer line. PP has submitted letter dtd. 25.10.18 issued by Nagar Nigam, Indore for disposal of extra treated waste water.
- xiv. Total waste 381.5 Kg/day, this consist all types of wastes (as Organic waste 228.9 Kg/day and non- organic waste 114.42 Kg/day), Inert waste 38.15 Kg/day. Different colored bins will be used for collection of biodegradable and non-biodegradable waste as per MSW Rules, 2016. Private sweepers and MSW handlers will be appointed by the RWA for door to door collection. The biodegradable portion of MSW will be treated at site. The non-biodegradable fraction like plastic, tin, glass etc. will be sold to local recyclers. Horticultural waste shall be collected and disposed-off with biodegradable waste. Rest inert MSW will be handed over to Municipal Council for final disposal. PP has submitted letter dtd. 25.10.18 issued by Nagar Nigam, Indore, Indore for disposal of solid waste.
- xv. Proposed Energy conservation measures are given below:
  - · Usage of low energy embodied locally available construction material. Usage of fly bricks, hollow bricks and fly ash mix cement for construction purpose. Usage of excavated soil and construction debris within the project site as filling material

  - LED lights are used for common area. Detailed calculation is given below: Installation of Solar panel of 50kW capacity on the Roof Top of "B" Block.

  - PVC insulated copper conductor cable will be used for wiring purpose.
  - LED lamps and low loss blasts shall be planned for Energy conservation. Solar powered street lights shall be used to conserve energy.
- xvi. Rainwater harvesting has been proposed to recharge ground water for which 08 recharge pits shall be constructed.
- xvii. Systematic circulation of internal traffic has been designed for the township. The total area covered under the roads is about 85.00 sq m. Access roads for driveways have been proposed to be provided to facilitate the free flow of traffic movement inside the premises
  - · All gates are manned with efficient security who can guide the entry and exit of
  - · Merging of vehicles will be performed only to left traffic from the exit gates and this
- xviii. PP has proposed the maximum height of the building is 36.0 m. PP has provided width of approach road 12 m, Front MOS9 m and Rear MOS 7.5m.

- xix. PP has proposed total car parking 343 ECS (Stilt- 133 ECS, Basement- 114ECS, Open-96ECS)
- xx. Adequate fire-fighting arrangements will be provided in the proposed Residential Complex. PP has obtained fire fighting NOC dtd. 03.04.2013 issued by UADD Bhopal. The fire-fighting arrangements to be provided in the complex are Wet riser system, Internal fire hydrants strategically located to cover maximum area, Fire pump, Sprinkler pump, Jockey pump, Sprinklers system, Two-way communication system, External yard hydrants, Portable fire extinguishers, Addressable microprocessor based fire alarm and detection system etc. as per NBC(2005).
- xxi. The total Green area will be developed in 975.0 m2 (10.06 % of total plot area) by planting 100 numbers of trees.
- xxii. PP has submitted the remediation plan and natural community resource augmentation plan corresponding to the ecological damage assessed and economic benefits derived due to violation in the tune of suggested guidelines by the committee and also reanalyze the cost of remediation in monitoring, soil management, RWH, additional plantation, OHS etc.
- xxiii. PP has proposed Rs. 2,23,62,748/- (Rs. 17,22,950/- as Remediation Cost and Rs. 2,06,39,798/- as EMP) for this project. As per recommendation of SEAC PP has submitted bank guarantee of INR 17,22,950/- towards Remediation Plan and Natural & Community Resource Augmentation Plan with following expenditure:-

Based on the information submitted at Para i to xx above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 636<sup>th</sup> meeting held on 14.09.2020 decided to accept the recommendations of 450<sup>th</sup> dtd. SEAC meeting held on dtd. 13.08.2020.

Hence, Environmental Clearance is accorded under the provisions of EIA notification dtd. 14<sup>th</sup> September 2006 and its amendments to the proposed "SHIVOM" Commercial and Residential By M/s. MSD Developers at Plot no. 578, MG Area, Tehsil and District Indore MP, Total Plot Area : 9290.30 sq.m and, Total Built- up area- 25,885 sq.m. by Partner, M/S MSD Developers,through Partner Shri Mayank Doshi, Plot No.8 PU-4 Commercial Scheme No. 54A.B. Road Indore (MP) - 452001 E-mail: shivom.msd@gmail.com Telephone No. 9010529529 subject to the compliance of the Standard Conditions and the following additional Specific Conditions as recommended by SEIAA & SEAC in its meetings.

## A. Specific Conditions as recommended by SEIAA:-

- 1. The fresh water supply arrangement should be met through Municipal Corporation, Indore (as per IMC letter dtd.25.10.18) and there should no extraction of ground water.
- 2. The inlet and outlet point of natural drain system should be maintained with adequate size of channel for ensuring unrestricted flow of water.

### 3. Disposal of waste water.

- a. PP should ensure disposal of waste water arrangement should be done in such a manner that water supply sources are not impaired.
- PP should ensure linkage with Nagar Nigam Indore (letter dtd. 25.10.18) for disposal of extra treated waste water.
- c. Ensure regular operation and maintenance of the STP.
- 4. The final disposal point for storm water will be municipal storm drain if storm water network is present. If storm water network is absent, the storm water surface runoff should be disposed off in proper way. The budget should be including in EMP plan for storm water management.

## 5. Solid Waste Management:

- a. Separate wet and dry bins must be provided at the ground level for facilitating segregation of waste.
- b. The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material.
- c. Ensure linkage with Municipal Corporation (letter dtd. 25.10.18) for final disposal of MSW.
- PP should ensure building height, road width, front MOS and side / rear as per approved layout.(dtd. layout of T & CP((vide letter no.4279/ Nagrin/ 2014/ dated 28.06.2014)

### 7. For firefighting:-

- a. PP should ensure distance of fire station approachable from the project site.
- b. As per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Indore) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place as per fire NOC dtd. 03.04.2013.

# 8. For Rain Water Harvesting, and Storm water management:-

PP should ensure the rain water harvesting with 08 recharging pits and these pits should be connected laterally to consume the surplus runoff. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.

#### 9. Car Parking:-

PP should ensure to provide car parking area for 343 ECS (Stilt- 133 ECS, Basement-114ECS, Open- 96ECS)

10. Green belt :-

PP should ensure plantation in an area of 975.0 m<sup>2</sup> (10.06 % of total plot area) of area is dedicated for the green belt development by planting 100 numbers of trees including two rows periphery and also explore the possibility to plant trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar, Saltree, Gulmohar etc.

- 11. PP should ensure to implement the CER activities such as Development of Pucca Road in Village Area in consultation with IMC, Toilet Construction at Hindi Saskiya Madhyamik Vidyalaya Kramank -9, Drinking Water Cooler with water purification system as required by Mijwan Welfare Society, Plantation along with roads as suggested by IMC, Solar Panels Installation in Government Buildings and Installation of Recharge well or pit at Govt. High School Vinoba Nagar, Donation at shree Ahilya Mata Goshala Jeevdaya Mandal, Donation at Mijwan Welfare Society, Donation at friends of Tribal's Society for which budgetary provision of Rs.: 2.16 Crore has been made. PP will carry out CER activities in consultation with District Administration/Commissioner, Indore Municipal Corporation.
- 12. PP should ensure to complete the activities listed under ecological remediation, Natural resource augmentation & community resource augmentation for a total amount of Rs. 17,22,950/-
- 13. PP shall carry out the works assigned under ecological damage, natural resource augmentation and community resource augmentation within a period of six months and submitted to same in MPSEIAA.
- 14. PP should ensure to submit half yearly compliance report and CER activity report with photographs of plantation in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC,GoI, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.

# B. Specific Conditions as recommended by SEAC

### I. Statutory Compliance

- i. The project proponent shall obtain all necessary clearance/permission from all relevant agencies including town planning authority before commencement of work. All the construction shall be done in accordance with the local building byelaws.
- ii. The approval of the Competent Authority shall be obtained for structural safety of building due to earthquakes, adequacy of firefighting equipment etc as per National Building code including protection measures from lightening etc.
- The project proponent shall obtain Consent to Establish/Operate under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and the Water (Prevention & Control of Pollution) Act, 1974 from the concerned State Pollution Control
- iv. The project proponent shall obtain the necessary permission for drawl of ground water/surface water required for the project from the competent authority.
   v. A certificate of adequacy of available neuron for the competent authority.
- v. A certificate of adequacy of available power from the agency supplying power to the project along with the load allowed for the project should be obtained.

- All other statutory clearances such as the approvals for storage of diesel from Chief Vi. Controller of Explosives, Fire Department, Civil Aviation Department shall be obtained,
- as applicable, by project proponents from the respective competent authorities. The provisions for the solid Waste (Management) Rules, 2016, e-Waste (Management) Vii.
- Rules, 2016, and the Plastics Waste (Management) Rules, 2016 shall be followed. The project proponent shall follow the ECBC/ECBC-R prescribed by Bureau of Energy Viii. Efficiency, Ministry of Power Strictly.

#### 11. Air Quality Monitoring and preservation

- Notification GSR 94(E) dated: 25/1/2018 MoEF& CC regarding Mandatory i. implementation of Dust Mitigation Measures for Construction and Demolition Activities
- for project requiring Environmental Clearance shall be complied with. A management plan shall be drawn up and implemented to contain the current ii. exceedance in ambient air quality at the site.
- The project proponent shall install system to carryout Ambient Air Quality monitoring iii. for common/criterion parameters relevant to the main pollutants released covering upwind and downwind directions during the construction period.
- Diesel power generating sets (15 kVA X 02) proposed as source of backup power iv. should be of enclosed type and conform to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Use of low sulphur diesel. The location of the DG sets may be decided with in consultation with State Pollution Control Board.
- Construction site shall be adequately barricaded before the construction begins. Dust, V. smoke & other air pollution prevention measures shall be provided for the building as well as the site. These measures shall include screens for the building under construction, continuous dust/ wind breaking wills all around the site plastic/tarpaulin sheet covers shall be provided for vehicles bringing in sand, cement, Murram and other construction materials prone to causing dust polluting at the site as well as taking out
- Sand, Murram, loose soil, cement, stored on site shall be covered adequately so as to vi. prevent dust pollution.
- vii.
- Wet jet shall be provided for grinding and stone cutting. Viii.
- Unpaved surface and loose soil shall be adequately sprinkled with water to suppress ix.
- All construction and demolition debris shall be stored at the site (are not dumped on the roads or open spaces outside) before they are properly disposed. All demolition and construction waste shall be managed as per the provisions of the Construction and X.
- The diesel generator sets to be used during construction phase shall be low sulphur diesel type and shall conform to Environmental (Protection) prescribed for air and noise xi.
- The gaseous emission from DG set (15 kVA X 02) shall be dispersed through adequate stack height as per CPCB standards. Acoustic enclosure shall be provided to the DG sets to mitigate the noise pollution. Low sulphur diesel shall be used. The location of the DG set and exhaust pipe height shall be as per the provisions of the Central Pollution Control Board (CPCB) norms.
- For indoor air quality the ventilation provisions as per National Building Code of India. xii.

#### III. Water quality monitoring and preservation

The natural drain system should be maintained for ensuring unrestricted flow of water. i. No construction shall be allowed to obstruct the natural drainage through the site, on wetland and water bodies. Check dams, bio-swales, landscape and other sustainable urban drainage systems (SUDS) are allowed for maintaining the drainage pattern and

- Buildings shall be designed to follow the natural topography as much as possible
   The total water requirements to be done.
- iii. The total water requirement during operation phase is 96 KLD out of which 43 KLD is fresh water requirement and 76 KLD will be the recycled water generated. Out of which 32 KLD treated water will be used for flushing and, while 17 KLD water will be used for horticulture.
- iv. The quantity of fresh water usage, water recycling and rainwater harvesting shall be to monitor to monitor the water balance as projected by the project proponent. The record shall be submitted to the Regional Office, MoEF& CC along with six monthly Monitoring
- v. A certificate shall be obtained from the local body supplying water, specifying the total annual water availability with the local authority, the quantity of water already committed the quantity of water allotted to the project under consideration and the balance water available. This should be specified separately for separately for ground water and surface water sources, ensuring that there is no impact on other users.
- vi. At least 20% of the open spaces as required by the local building bye-laws shall be previous. Use of Grass pavers, paver blocks with at least 50% opening, landscape etc.
- vii. Installation of dual pipe plumbing for supplying fresh water for drinking, cooking and bathing etc and other for supply of recycled water flushing, landscape irrigation, car washing, thermal cooling, conditioning etc. shall be done.
- viii. Use of water saving devices/fixtures (Viz. low flow flushing systems; use of low flow flow flushing systems; use of low flow plan.
- ix. Separation of grey and black water should be done by the use of dual plumbing system. In case of single stack system separate recirculation lines for flushing by giving dual plumbing system be done.
- x. Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- xi. The local bye-law construction on rain water harvesting should be followed. If local bylaw provision is not available, adequate provisions for storage and recharge should be followed as per the Ministry of Urban Development Model Building bylaws, 2016. Rain recharging as per the CGWB norms.
   xii. A rain water baneating of the construction of the constru
- xii. A rain water harvesting plan needs to be designed where the recharge bores of minimum one recharge bore per 5,000 square meter of built up area and storage areas where ground water recharge is not feasible, the rain water should be harvested the Competent Authority.
   xiii. For rainwater barbotiae, 00 minimum one day of the rainwater barbotiae.
- xiii. For rainwater harvesting, 08 recharge pits will be constructed for harvesting rain water. The total recharge capacity of these pits about 61.94 m<sup>3</sup>/hr . Mesh will be provided at the roof so that leaves or any other solid waste/debris will be prevented from entering
- xiv. All recharge should be limited to shallow aquifer. No ground water shall be used during construction phase of the project.
- xv. Any ground water dewatering should be properly managed and shall conform to the approvals and the guidelines of the CGWA in the matter. Formal approval shall be taken from the CGWA for any ground water abstraction or dewatering.
- xvi. The quality of fresh water usage, water recycling and rainwater harvesting shall be measured and recorded to monitor the water balance as projected by the project proponent. The recorded shall be submitted to the Regional Office, MoEF& CC along with six monthly Monitoring report.
- xvii. Sewage shall be treated in the STP based on MBBR based technology (Capacity 100 KLD), treated effluent from STP shall be recycled/re-used for flushing. AC makes up
