
- C. **The following cases related to Billua Cluster were discussed in SEIAA :- 1946/2014, 1981/2014, 2050/2014, 2066/2014, 2185/2014 & 2221/2015** and after perusal of the recommendation of 34th SEAC-II meeting dtd. 25.06.2016 where it was recorded that :-


"The above cases were presented by the respective PP's and their consultant before the committee. After presentation committee observed that all the above six mines are located adjacent to each other and the nearest mine registered as case no.-2185/14 (Smt. Asha Sharma W/o Shri Suresh Sharma, Ahukhana Ghas Mandi, Gwalior (MP)-477001) is only 480 meters away to the existing billua cluster (which consist of an area of approx 102.356 ha with > 55 mining leases) as per the revised certificate issued by the mining officer vide letter no. QL-23/2011/811 dated 13/06/2016 and since the distance of the nearest mine is < 500m. these six mines shall also become part of Billua cluster and should be considered with them for grant of EC only after conducting EIA & Public Hearing. PP submitted that the EIA of billua cluster is already completed and public hearing is also conducted in the last week".


The above action is hereby approved. SEAC may be informed accordingly.
