


## Minutes of the 654<sup>th</sup> Meeting of SEIAA dated 28.01.2021



- (1) This is a project pertaining to mining of Marble Mine in MLA of 1.85 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary/Biosphere Reserve thus it is not attracted by the general conditions, PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter no 3975 dated 24/10/19 has reported that there are 07 more mines operating or proposed within 500 meters around the said mine with total area of 44.32 ha including this mine and falls under category 'B-1' by virtue of its location and mining lease area. ## B. Policy Decision


It has been observed that multiple cases which were granted EC transfers as per the prevailing mining plan have now requested for consideration of revised mining plan approved by competent authority.

SEIAA recommends these cases to SEAC for examination as per prevailing rules and guidelines.


