"-----The case was scheduled for the presentation but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. It was also observed that entire lease area surrounded by habitations in the NE & NW direction of the lease and other sensitive features. Moreover, so far PP has not submitted the query/ clarification which was asked in 448<sup>th</sup> SEAC meeting dated 23-07-20. Hence the committee w.r.t. NGT order dated 21.07.2020 after deliberation recommends that this case can not be considered for grant of TOR/EC on above sensitivity and file may be sent to SEIAA for onward necessary action.

As per above observation of SEAC, it was decided to reject the case as case cannot be considered for grant of TOR/EC looking to above environmental sensitivity. Copy to PP and all Concerned.."
