".....The case was presented by the PP and their consultant wherein as per Google image based on coordinates provided by PP, committee observed that the entire lease area is submerged in the water. Even through the back Google images no area could be noticed where sand mining is possible. Thus, committee after deliberation recommends that this case cannot be considered for grant EC and file may be sent to SEIAA for onward necessary action".

As per above recommendation of SEAC, this case can not be considered for environmental clearance as entire lease area is submerged in water. After discussion and deliberation, it was decided to reject the case considering environmental sensitivity. Copy to PP and all concerned.

As per above decision, you are hereby informed that your case is rejected as EC can not be considered looking to the environmental sensitivity.
